**16.00**      **THE POWER OF PLACE**

Recent polling conducted by Ipsos Mori and NLGN found that the public know little about the “devolution revolution”. This survey showed that three quarters of people know little or nothing about plans to devolve power to a local level.

While on the whole the public is supportive of the need to devolve power to local level and are four times as likely to trust local than national politicians, abiding concerns about variations in services – so called “postcode lotteries” persist. The public are not yet where we would like them to be on the merits of devolution.

This session will explore public attitudes in more depth and examine what arguments might be used to further persuade the public of the case for greater devolution, local decision making and greater fiscal autonomy.
